**Product Description**

On the Final Redemption Date, if not early redeemed, a Capped Outperformance Certificate is redeemed at a cash amount, depending on the performance of the Underlying, but which will not exceed the Maximum Redemption Amount, or by delivery of a number of Underlyings as specified below. The Products allow the holder thereof to benefit from , with leverage, in any positive performance of the Underlying up to the Cap.

Therefore, if the value of the Underlying develops positively, i.e. if the Final Level of the Underlying is at or above the Strike, the Products will be redeemed by payment of a cash amount which disproportionately reflects such positive change and an investment in the Products will outperform a comparable direct investment in the Underlying up to the Cap.

Any negative performance of the Underlying will be reflected directly, i.e. without leverage. If the Final Level of the Underlying is below the Strike, the Products will be redeemed by delivery of a number of Underlyings as specified below. Therefore the risk associated with an investment in the products is comparable to the risk associated with a direct investment in the Underlying.

## II. Profit and Loss Prospects

The potential return on a Product is limited to the positive difference between the Maximum Redemption Amount and the Issue Price (or, if different, the price for which the investor purchased the Product). The Products provide for an upside leverage effect, which means that if the Final Level of the Underlying is at or above the Strike this will result in a disproportional (positive) return on the Product, but the Final Redemption Amount will not exceed the Maximum Redemption Amount.

The potential loss associated with an investment in such Products is linked to the negative performance of the Underlying. If the Final Level of the Underlying is below the Strike the Products will

be redeemed by delivery of a number of Underlyings specified below. In this case, the loss corresponds to the difference between the invested amount and the value of the number of Underlyings specified in the Ratio. The value of these Underlyings may be considerably lower than the invested amount. ### III. Significant Risks for Investors

The following risk disclosure cannot disclose all the risks associated with an investment in the Products. Therefore, potential investors in Products should consult the Base Prospectus and the Final Terms and their client advisor as to the product specific risks before making an investment decision.

#### 1. Issuer Risk

Investors bear the credit risk of the Issuer. The Products' retention of value is dependent not only on the development of the value of the Underlying, but also on the creditworthiness of the Issuer, which may change over the term of the Product. The credit rating of the Issuer is not a guarantee of credit quality. In case of the Issuer's insolvency or bankruptcy the investors in the Products may lose their entire investment.

The Products are direct, unconditional, unsecured and unsubordinated obligations of the Issuer. #### 2. Product Risks

#### **Risk of total loss**

Products involve a high degree of risk, and prospective investors in the Products should recognise that, under certain circumstances, Products may have a redemption value of zero. #### **Capped Profit Potential**

Investors in Products should be aware that the profit potential in relation thereto is capped. Therefore, an investment in Products may lead to a lower return than a direct investment in the Underlying(s).

#### **Unpredictable Market Value for Products**

During the term of a Product, the market value of, and the expected return on, such Product may be influenced by many factors, some or all of which may be unpredictable. Many

economic and market factors will influence the market value of a Product. The Issuer expects that, generally, the value and volatility of the Underlying(s) on any day will affect the market value of such Product more than any other single factor. However, a potential investor should not expect the market value of a Product in the secondary market to vary in proportion to changes in the value of the Underlying(s). The return on a Product (if any) may bear little relation to, and may be much less than, the return that the investor therein might have achieved if such investor had invested directly in the Underlying(s).

The market value of, and return (if any) on, a Product will be affected by a number of other factors, which may be unpredictable or beyond the Issuer's control, and which may offset or magnify each other, including, without limitation:

- supply and demand for such Product, including inventory positions of any other market maker;
- the expected frequency and magnitude of changes in the market value of the Underlying(s) (volatility);
- economic, financial, political or regulatory events or judicial decisions that affect the Issuer, the Underlying(s) or the financial markets generally;
- interest and yield rates in the market generally;
- the time remaining until the Final Redemption Date;
- if applicable, the difference between the Level or Commodity Reference Price, as applicable, and the relevant threshold specified in the applicable Terms and Conditions;
- the Issuer's creditworthiness, including actual or anticipated downgrades in the Issuer's credit ratings; and
- dividend payments on the Underlying(s), if any.

Some or all of these factors may influence the price of a Product. The impact of any of the factors set forth above may enhance or offset some or all of any change resulting from another factor or factors.

In addition, certain built-in costs are likely to adversely affect the market value of Products. The price at which the Issuer will be willing to purchase Products from a holder in secondary market transactions, if at all, will likely be lower than the original Issue Price.

#### **Exposure to the performance of the Underlyings**

Each Product will represent an investment linked to the performance of the Underlying(s) and potential investors should note that any amount(s) payable or other benefit to be received under the Products will generally depend upon the performance of the Underlying(s). The past performance of the Underlyings is not indicative of the future performance.

#### **Exchange Rate Risk**

The Underlying(s) may be denominated in a currency other than that of the Issue Currency or, if applicable, the Settlement Currency for such Product, or the Underlying(s) may be denominated in a currency other than, or the Issue Currency or, if applicable, the Settlement Currency may not be, the currency of the home jurisdiction of the investor in such Product. Exchange rates between currencies are determined by factors of supply and

demand in the international currency markets, which are in particular influenced by macro economic factors, speculation and central bank and government intervention (including the imposition of currency controls and restrictions). #### **Secondary Market**

Products may have no established trading market when issued and one may never develop. If a market does develop, it may not be liquid. Therefore, investors may not be able to sell their Products easily or at prices reasonably acceptable to them.

Under normal market circumstances, the Issuer will endeavour to provide a secondary market for Products, but is under no obligation to do so. Upon investor demand, the Issuer will endeavour to provide bid/offer prices for products, depending on actual market conditions. There will be a price difference between bid and offer prices (spread).

#### **Early Redemption**

The investors must be aware of a possible early redemption of the Product.

Upon the occurrence of an extraordinary event, the Calculation Agent and the Issuer, acting together, have the right to, among other things, early redeem the relevant Products. If the Issuer exercises such early redemption right(s), investors should be aware that the early redemption price may be considerably lower than the Issue Price (or, if different, the price the relevant investor paid for such product) and/or the Final Redemption Amount that would otherwise have been paid on the Final Redemption Date.

#### **Further product specific risks**

Investors should be aware that an investment in these Products generally results in a loss upon redemption if the Final Level of the Underlying is below the Strike. Consequently, the potential loss associated with an investment in such Products is linked to the negative performance of the Underlying. Any change in the value of the Underlying below the Strike will generally result in a proportional change in the market value of (and expected return on) the Products.

In the case of a physical settlement, delivery of the Underlying will not be made on the date of valuation of the Underlying, but on the Final Redemption Date (or the first Delivery Day thereafter). Accordingly, an investor in the Products will be exposed to the risk that the value of the Underlying to be delivered will decline between the date of valuation and the time of delivery. Furthermore, if the Product is physically settled, any investor therein will be exposed to the risks relating to the Underlying to be delivered (i.e. the Share, Share Issuer).

Although the Products do not provide for a downside leverage effect, if an investor purchases such Products above the Issue Price in the secondary market, it should be aware that (i) the market value of such Products may nevertheless disproportionately decline for such investor if the value of the Underlying decreases after the date of such purchase (in

particular, if the value of the Underlying remains above the Strike), and (ii) the greater the multiplier or leverage factor of the Product, the greater such disproportionate decline in the market value thereof.

Investors in Products should be aware that the profit potential in relation thereto is capped, which means that investors in such Products will not participate in any performance of the Underlying that exceeds the Cap. Therefore, an investment in such Products may lead to a lower return than if the investor had made a direct investment in the Underlying.
