Product Description

On the Final Redemption Date, if not early redeemed and if no Barrier Event has occurred, a Bonus Certificate is redeemed at a cash amount, which amount is dependent upon the performance of the Underlying, but which will not be less than the product of the Denomination and the Conditional Protection and not more than the Maximum Redemption Amount, which means that an investor's return in the Products is capped. The Products enable the holder thereof to benefit from a limited participation in any positive performance of the Underlying up to the Cap. So long as no Barrier Event has occurred, the Conditional Protection provides investors in the Products with a risk buffer.

Alternatively, if a Barrier Event has occurred, the Product no longer offers conditional protection and, consequently, the holder thereof can no longer expect to receive at least the product of the Denomination and the Conditional Protection on the Final Redemption Date, irrespective of the Underlying's performance. II. Profit and Loss Prospects

The Products provide for an upside participation effect. The potential return on a Product is limited to the positive difference between the Maximum Redemption Amount and the Issue Price (or, if different, the price for which the investor purchased such Product).

Exposure to the performance of the Underlyings
