#### **Product Description**

A Range Accrual Warrant allows the holder thereof to benefit from a decrease in the value of the Underlying down to the Lower Range Limit and an increase in the value of the Underlying up to the Upper Range Limit. The Warrants entitle the investor upon exercise on the Exercise Date to receive an amount of cash from the Issuer on the Settlement Date, which amount is dependent upon the number of Observation Dates during the Observation Period on which the Final Level of the Underlying was neither at or above the Upper Range Limit nor at or below the Lower Range Limit. Such accumulated amounts are also reflected in the prices in the secondary market of the Product.

The Upper Range Limit and Lower Range Limit for the Underlying are calculated on the Launch Date and equal to a percentage of the Underlying's Initial Level.

If on every Observation Date during the Observation Period the Final Level of the Underlying was either at or above the Upper Range Limit or at or below the Lower Range Limit, then the cash amount to be paid upon exercise will be equal to zero and investors will suffer a total loss of their investment. # **II. Profit and Loss Prospects**

If on every Observation Date during the Observation Period the level of the Underlying was either at or above the Upper Range Limit or at or below the Lower Range Limit, then the cash amount

to be paid upon exercise will be equal to zero and investors will suffer a total loss of their investment.

# **III. Significant Risks for Investors**

- dividend payments on the Underlying(s), if any.

Some or all of these factors may influence the price of a Product. The impact of any of the factors set forth above may enhance or offset some or all of any change resulting from another factor or factors.

In addition, certain built-in costs are likely to adversely affect the market value of Products. The price at which the Issuer will be willing to purchase Products from a holder in secondary market transactions, if at all, will likely be lower than the original Issue Price.

# Exposure to the performance of the Underlyings

#### **Exchange Rate Risk**
