Product Description

Barrier Reverse Convertibles are primarily targeted at investors expecting (i) the volatility of the Underlyings to decrease, (ii) the value of the Underlyings to remain constant or to slightly increase and (iii) that no Barrier Event will occur, in each case, throughout the term of the Products. On the Final Redemption Date (if not early redeemed), a Product is redeemed at a cash amount equal to 100% of the Denomination if (i) no Barrier Event has occurred or (ii) a Barrier Event has occurred and the Final Level of each Underlying is at or above its Strike. Alternatively, if a Barrier Event has occurred and if the Final Level of at least one Underlying is below its Strike, a Product is redeemed on the Final Redemption Date (if not early redeemed) by payment of a cash amount. In such case, the Final Redemption Amount is linked to the negative performance of the Worst-Performing Underlying.

The Products provide for the payment of a Payout Amount on the Payout Date which is dependent upon whether the Payout Threshold has been reached on the Payout Observation Date. II. Profit and Loss Prospects

The potential return on the Product is limited to the aggregate of the Interest Amounts, Premium Amounts and the Payout Amount, if any, scheduled to be paid under the Product. This means that the return on the Product is capped while a direct investment in the Underlyings typically is not.
