II. Profit and Loss Prospects

The potential return on a Product is limited to the Coupon scheduled to be paid at maturity of the Product.

If the Products are early redeemed, investors may receive a redemption amount that is considerably lower than the Final

Redemption Amount that would have otherwise been received. In such case, the investor in the Product may suffer a partial loss on its investment.

III. Significant Risks for Investors

1. Issuer Risk

Investors bear the credit risk of the Issuer. The Products' retention of value is dependent on the creditworthiness of the Issuer, which may change over the term of the Product.
